- in India. The amount is spent on wellness centres for different cities are shown seperatley for better management.
- 3) Donations received from crowdfunding organisation are net off their service charges deducted from donation amounts.
- 4) There is stay granted by Bombay High Court for collection of contribution payable to the Public Trust Administration Fund @2% on gross annual income chargeable to contribution (As per Schedule - IX - C). Therefore amount payable on account of contribution is not provided for.
- 5) Donations received with the specific direction for corpus donations are directly credited to the trust Corpus Fund account.
- 6) The previous year's figures where not in a comparable state, at this stage, due to change in presentation.
